Take ABC Exams at 2016 ABI Events

The American Board of Certification (ABC) is pleased to announce our 2016 exam schedule in partnership with ABI's upcoming conferences (see the chart). If an applicant is unable to travel, the ABC can still accommodate you, and many potential applicants have chosen to take the examination in their offices. The \$75 fee is very reasonable, and a proctor will come to your office to administer the test. The ABC staff needs at least two weeks' notice in order to schedule a proctor.

In 2015, an ABC Prep Course Task Force was formed, and a new prep course is now available to potential applicants. The prep course is available to ABI members for \$295 at abi.org/abcprep. Very special thank yous go to ABC Chair **Candace C. Carlyon** (Morris, Polich & Purdy, LLP; Henderson,
