Another ABC-Certified Specialist Is Appointed To The Bench

Kenney was educated at Virginia Commonwealth University, where he received his bachelor's degree in political science and graduated magna cum laude. He obtained his law degree at the University of Virginia.

Prior to ascending to the bench, Kenney led

Miles & Stockbridge, P.C.'s Tyson's Corner bankruptcy and creditors' rights practice, where he was resident for more than 22 years.

It was during this long tenure that Kenney built a large and very successful practice representing financial institutions and others in many major cases in the Washington, D.C. region.

Recently Kenney was asked

why he would give up such a successful law practice at this the prime of his career.

"I've always been interested in public service, and I simply want to give something back to the community," he said.

However, he also spoke of missing the camaraderie of his former law partners. These remarks come as no surprise to all who have known Kenney for all of these years — and in many ways, they sum up his best qualities. •
